**SUMMARY ANNUAL REPORT
FOR THE RETIREMENT PLAN OF MARATHON OIL COMPANY**

This is a summary of the annual report for the Retirement Plan of Marathon Oil Company, EIN 25-1410539, Plan No. 001, for period January 1, 2006 through December 31, 2006. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the Plan are provided through insurance and through a trust fund. Plan expenses were \$38,489,613. These expenses included \$988,787 in administrative expenses and \$37,500,826 in benefits paid to participants and beneficiaries. A total of 4,265 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$599,008,388 as of December 31, 2006, compared to \$461,531,665 as of January 1, 2006. During the Plan year the Plan experienced an increase in its net assets of \$137,476,723. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$175,966,336 including employer contributions of \$111,000,000, realized gains of \$2,156,673 from the sale of assets, and earnings from investments of \$62,809,663.

Minimum Funding Standards

An actuary's statement shows that enough money was contributed to the Plan to keep it funded in accordance with the minimum funding standards of ERISA.

Basic Financial Statement

Benefits under the Plan are provided through a trust fund. Plan expenses were \$257,243,805. These expenses included \$257,243,805 in benefits paid to participants and beneficiaries. A total of 16,348 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The Plan had total income of \$419,974,932 including employer contributions of \$41,509,363, employee contributions of \$74,263,355, and earnings from investments of \$275,078,985.
