## Overview

At Marathon Petroleum Corporation (MPC) we're working to enhance life's possibilities. Every day we live our core values of safety & environmental stewardship, integrity, respect, inclusion and collaboration. By reliably providing affordable, safe and abundant energy from coast-to-coast, we look to power today. We're inspired to make tomorrow even better, and we're just getting started.

Our Canton refinery is located 60 miles southeast of Cleveland, Ohio, and has a crude oil refining capacity of 100,000 barrels per calendar day (bpcd). In December of 2014, a condensate splitter was installed, increasing the refinery's capacity to process condensate from the Utica shale region. The refinery processes sweet and sour crude oils into gasoline, distillates, asphalt, roofing flux, propane, refinery-grade propylene and slurry. Product distribution occurs through pipeline, transport truck and rail.
