

# St. Paul Park Refinery



## Overview

At Marathon Petroleum Corporation (MPC) we're working to enhance life's possibilities. Every day we live our core values of Safety & Environmental Stewardship, Integrity, Inclusion, Collaboration and Excellence. By reliably providing affordable, safe and abundant energy from coast-to-coast, we look to power today. We're inspired to make tomorrow even better, and we're just getting started.

Our St. Paul Park refinery (SPPR) is located along the Mississippi River and part of the Twin Cities community. Originally built in 1939, it has a crude oil refining capacity of 105,000 barrels per calendar day (bpcd). The refinery manufactures gasoline, distillates, asphalt, heavy fuel oil, propane and refinery-grade propylene, which is produced using sweet crude from the Bakken region in North Dakota as well as various grades of Canadian sweet and heavy sour crude. Products are delivered from the refinery by pipeline, truck, rail and barge.

At MPC, the health and safety of our employee, contractors and communities we call home is a top priority. We take steps to ensure an accident-free, incident-free workplace. We've implemented cutting-edge safety measures at the refinery, and are recognized as an industry leader.
